Pool hire and additional staff costs are estimated, the joint event includes an extra part day.

Normally our national championships would hope to break even, thanks of course, to Edinburgh District Council and sponsorship, both of which are built into the above figures as per your letter.

The major changes in raising the status of the event relate to the award of prize money, subsidies to invited swimmers of world standing, additional pool hire, marketing costs and the like.

Your proposed contribution of £15 000 is as budgeted above ie. £35 000 less £15 000.

The control of expenditure will be the responsibility of the organising committee under the chairmanship of Douglas Brown.

I understand that the obtaining of programme advertisers and event sponsors is the responsibility of Miss Fraser of EDC Marketing Department assisted by Mr Wallace of Barracuda who act for the SASA.

SCOTTISH NATIONAL CHAMPIONSHIPS: EDINEURCH INTE

I refer to Mr Black's letter of 23 March 1990 and a subsequent meeting of the joint planning group.

There appears to be a little concern or confusion which requires your attention. The budget costs for pool hire estimated at £12,000 was, I understood, a global estimate to include any small extra items like overtime payments and in particular the use of the scoreboard, I note from the minute of the meeting of the joint planning group held on 4 April 1990 that there is the possibility of additional costs for Omega to send their team to operate data handling. I would hope these additional costs can be avoided perhaps by using the scoreboard only for display purposes which would not, I believe, require the Omega team; in which case, data handling i.e. the production of results, could be dealt with by manual input to an Association computer (which is what happens at most other swim meets).

I believe the other budget items detailed in Mr Black's letter of 23 March 1990 are broadly agreed by "both sides" of the joint planning group and it is just your general approval which is required, together with resolution of the matter referred to above.

SCOTTISH NATIONAL CHAMPIONSHIPS AND EDINBURGH INTERNATIONAL MEET

The Joint Planning Group at their meeting on 23rd April, 1990 requested and record their concern regarding the continuing write confusion which exists over the provision of a data handling service for the Joint Meet.

It is our understanding that the District Council staff are unable to provide the data handling operational capability, and as this procedure is recognised as essential to the operation of any major Meet, we must therefore examine as a matter of urgency the following options.

That the District Council provide the expertise through the services (within the terms of your own contractual arrangements with Omega) to operate the existing data handling facility within the Royal Commonwealth Pool. This would provide the service necessary for the Meet. Any costs to be contained within the overall facility hire.

οr

That the SASA be permitted to connect with the data output from the OSM6 and provide their own independent data handling system. This would be operated by SASA personnel in a suitable area, eg. the rowing tank area.

or

3. That the SASA provide the following timing equipment, OSM6 and result display units, this equipment being manned by SASA personnel with the appropriate reflection in staffing costs.

You will appreciate that the above options have differing implications in terms of the organisation and quality of Meet presentation. It is therefore considered vital that decisions are made prior to our next scheduled meeting on 8th May.
