107/84 APOLOGIES FOR ABSENCE

An apology for absence was received from Mrs. A. Manson (Midland District). Mr. D. Phinn attended as substitute.

108/84 PRESIDENT'S ADDRESS

Since the last meeting, the President had attended the 8 Nations Swimming and Water Polo Contests at Cardiff, the 6 Nations Water Polo Tournament at East Kilbride, and the O.C.L. National Championships and he congratulated the swimmers and players on their successes. He had attended many Committee meetings also and thanked Mr. Cape for substituting for him on occasion - the Runciman and Junior Inter District Water Polo Contests.

The President congratulated the Scottish members of the Olympic Team and the European Junior Championships Team on their successes, and Mr. Black on successfully getting through the change of rule for Masters Swimming at the FINA Congress.

He reported that Mrs. Mary Sreenan was still in hospital following her road accident and on behalf of members, wished her a speedy recovery.

109/84 MINUTES

The Minutes of the previous meeting held on 17th June 1984, which had been circulated, were, confirmed as correct and signed by the Chairman.

110/84 WATER POLO TIMING EQUIPMENT

The equipment had broken down in use, but the matter was being dealt with.

111/84 FINA REPRESENTATIVE TO INSPECT THE R.C.P. (Previous Minute 78/84)

The General Secretary reported that he had spoken with Mr. Artie Shaw, from FINA regarding the problems relating to the Pool improvements for the Commonwealth Games. Mr. Shaw had thought it possible that Mr. Alan Clarkson might be given authority from FINA to attend Commonwealth Games meetings and advise on technical matters.

112/84 PROPOSED WATER POLO TOURNAMENT 1986 (Previous Minute 79/84)

The English A.S.A. had enquired whether financial assistance would be available for their team. Members supported the Water Polo Committee's recommendation that no financial assistance be given.

The General Secretary reported that Mr. Artie Shaw had confirmed New Zealand's interest in the Tournament. They would meet their own travel costs, but would be grateful for any support once in Scotland. Mr. Sha had given him the name of a contact for possible sponsorship and he would discuss this with the Directors of Swimming and Administration.

The General Treasurer stressed that the Tournament must be self-financing. Members understood that the Commonwealth Games Committee were giving the use of the R.C.P. free of charge for the Tournament, so the main costs would be on accommodation.

113/84 JOHN Y. COUTTS MEMORIAL AWARD (Previous Minute 81/84)

Samples of the award were not yet available due to problems with the granite. The North District had not yet paid their donation to the fund.

114/84 PURCHASE OF TIMING EQUIPMENT PADS (Previous Minute 85/84)

Mr. Macfadyen apologised for not yet having supplied his technical report. Aware of the urgency due to the Sports Council's cash-flow system, he would prepare it immediately, now that he had received a full FINA report regarding timing equipment.

115/84 HIRE OF TIMING EQUIPMENT (Previous Minute 85/84)

Aberdeen A.S.C. had paid the hire charge for the timing equipment under protest, detailing in a letter points of concern regarding maintenance. Mr. Macfadyen assured Council that at least three times a year, the pads were inspected in detail and on another three occasions they were inspected for minor faults and he therefore refuted the allegations made by Aberdeen A.S.C. He understood that the Association could not afford the cost of repairs by Omega, but if they wished to take out maintenance with Omega, he would support this.

RESOLVED: That repair and maintenance of the timing equipment be carried out by Mr. Macfadyen as previously.

116/84 SHORT COURSE CHAMPIONSHIPS VENUE (Previous Minute 86/84)

Mr. Robb expressed concern regarding Aberdeen District Council grants for the Short Course Championships, which were given in retrospect. The Leisure and Recreation Committee had turned down the 1983 grant application, but it had still to be considered by the full Council. Recognising the urgency for finalising the 1983 Championships financial statement, he would make further enquiries and report back.

- RESOLVED: 1. That the 1984 Championships be held in Aberdeen.
 - That Mr. Robb make application to the District Council for a grant for the 1984 Championships.
 - That the Championships Organising Committee finalise the financial statement for the 1983 Championships as quickly as possible.
- 117/84 LOCAL SPORTS COUNCILS' SEMINAR (Previous Minute 93/84)

It was understood that certain duties relating to sports grants had been taken over by the City of Edinburgh District Council.

118/84 EUROPEAN YOUTH CHAMPIONSHIPS TEAM COACH (Previous Minute 98(2)(b)/84)

At the request of the Association, Ian Mason had attended the Championships as a Coach, with full expenses of £500 to be met by the Association. It was now understood however, that one of the original three coaches had withdrawn from the team.

RESOLVED: The G.B. be asked, in view of the coach's withdrawal, to consider Ian Mason an 'official' coach with his expenses being met in the usual manner by G.B.

119/84 SHALLOW END STARTING (Previous Minute 98(3)(a)/84)

The water level had been raised at the National Championships.

120/84 CENTENARY YEAR (Previous Minute 98(4)/84)

Mr. T. Nichol and Mr. G. Philp (East District) and Mr. P. Smith (Midland District) were nominated and accepted as members of the Centenary Committee. Nominations from the other Districts were not yet made.

121/84 REPORT OF THE GENERAL SECRETARY

Report of FINA Congress

(a) FINA Synchronised Swimming Technical Committee

Members congratulated Mrs. Mary Black on her appointment to the FINA Synchronised Swimming Technical Committee.

The General Treasurer, while supporting Mrs. Black's appointment, expressed concern at the cost to the Association of having FINA representatives.

(b) Masters Rule Change

Mr. Black had been successful in getting his proposed Masters Rule change passed at the FINA Congress.

RESOLVED: That he include in Swimscene, clarification of what the Rule now meant.

(c) Members expressed concern at the lack of interest and input by G.B. into FINA regarding the Rules of Swimming.

RESOLVED: That Council's concern be expressed to G.B.

2. Commonwealth Games

(a) Minutes of Swimming Technical Committee Meeting of 25th June

Members noted that Mr. Black had requested an allocation of approx. 100 tickets for the Association for aquatic events.

3. General Report

(a) G.B. Minutes of 6th July

Mr. Black expressed great concern regarding the accuracy of the G.B. Minutes. The Secretary of the Welsh A.S.A. shared this concern and had written to Mr. Hassall accordingly.

RESOLVED: That the Association write to Mr. Hassall stressing the need for accurate G.B. Minutes.

Arising from the Minutes:

(i) Technical Committees: Representation

It was recommended to each constituent country that the Technical Committees be set up as previously proposed: 3 from England, one from Wales and one from Scotland. Members discussed the matter, taking into account the decision of the A.G.M. to support 2 members from each constituent country for the Technical Committees.

RESOLVED: That the recommendation of 3-1-1 be accepted, and that the Association members be asked at the next A.G.M. to support this action.

(ii) Sports Council Meeting: G.B. Development Plan

Members agreed on the importance of the constituent countries being represented at the meeting with the Sports Council to discuss the finances of G.B. and the proposed Development Plan.

Members expressed disappointment in the Development Plan, feeling it to be static and lacking perspective. They proposed it be a one year plan only and that it be passed to the proposed Technical Committees for consideration and action for the future.

(iii) Beechams/Lucozade Club Championships

The Association had written to G.B. asking why the Club Championships were open to English Clubs only, when in fact past recommendations had been for a G.B. event. In reply, the Minutes stated there was only money available for an England event. Members queried whether Beechams/Lucozade had been aware of whether they had been sponsoring a G.B. event or an England only event and it was

RESOLVED: That a letter be sent to Beechams/Lucozade on the matter.

(b) Commonwealth Games

(i) 'B' Finals

Mr. Black reported that at the Sports Division Meeting of 16th August, it had been reported that 'B' Finals for the Games had not been approved. Convinced of the importance of 'B' Finals, members

RESOLVED: That member countries of the Commonwealth be asked for their views on the inclusion of 'B' Finals and, if in favour, their replies to be passed to the Commonwealth Games Committee for the matter to be reconsidered.

(ii) 1985 Events

Mr. Borthwick, Chairman of the Games Organising Committee had expressed willingness to help in any way he could regarding pre-Games events in 1985. It was understood however, that at present there would be no reduction in hire charges for facilities for such events.

(iii) 1985 Triangular Meet

Members discussed the proposed meet in detail, considering the availability of teams, the format, and the financial aspects, including possible sponsorship. They agreed it was a viable project, but required great commitment from members of the Association.

RESOLVED: That the meet, in some form, go ahead and that the interested countries be invited, officially, on G.B. notepaper, to take part (with the U.S.A. in place of Australia, who had withdrawn) - on the understanding that it be self-financing - and that approaches be made to possible sponsors.

Also, that a Meet Sub-Committee be set up under the organisation of the Executive and the Directors of Swimming and Administration.

4. J. Y. COUTTS AWARD

Details of the costs involved in producing the John Y. Coutts Award were given. Members expressed some concern at whether the donations to the fund were sufficient. It was noted that Bon Accord Club would cover the cost of the die.

RESOLVED: That the Report of the General Secretary be accepted.

122/84 REPORT OF THE GENERAL TREASURER

1. Statements of Per Capita and Annual Competitive Fees

Members considered the statements. Anomalies were noted and the

Director of Administration was asked to query these with the Clubs involved.

The Director of Swimming felt that the statements could be an excellent means of analysing various aspects of club development.

2. Budget

A presentation to Council regarding budget submission to the Sports Council for 1985 was submitted by the Directors of Swimming and Administration, giving details of 1984 expenditure and proposed costings for 1985. The probable financial deficit at the end of the current year was brought strongly to members' attention.

RESOLVED: That the projected 1984 budget figures be accepted.

Regarding the 1985 budget, members were of the opinion that the Water Polo Budget should be cut back in relation to the Swimming Budget. They also supported an allocation of funds for updating the computer.

RESOLVED: That a Budget Working Party - the Executive, one member from each District and the Directors of Swimming and Administration - meet with Committee Conveners on 8/9 September to discuss and, where necessary, amend the budgets, and allocate responsibility for preparation of the detailed grant application to the Sports Council.

123/84 REPORT OF THE DIRECTOR OF SWIMMING

The Director submitted his Report. Arising therefrom:

Notification of Events

It was noted that District Secretaries requested notification of all events being organised.

The Director was reminded that proposed holidays and attendances at meets down south should be cleared with the General Secretary.

Contract

The Director had not yet signed his contract, as it now appeared that it could be possible for him to participate in a superannuation scheme. This situation was currently being investigated and if feasible, would be included in the contract.

4. Car Loan

The Director asked about the possibility of a short term loan from the Association to assist with the purchase of a new car.

RESOLVED: That at the present time, such a loan was not possible, but that the matter be reconsidered at the next meeting of Council.

RESOLVED: That the Report of the Director of Swimming be accepted.

124/84 REPORT OF THE DIRECTOR OF ADMINISTRATION

The Director submitted his Report. Arising therefrom:

1. Standing Committee Reports

RESOLVED: That for future Council Meetings, Committee Conveners submit a report setting out their Committee's decisions, proposals and recommendations which require Council's approval. A copy of minutes and reports would still be submitted to the office for record purposes and would be available to Council members wishing to read same.

2. Water Polo: Annual Competitive Fees (Previous Minutes 101(3) and 102(d)/84

The Executive had agreed that ten clubs had taken part in games with players for whom no Annual Competitive Fee had been paid. They had agreed that the Clubs should be fined, but that the competition results should stand. To date, ony two clubs had paid their fines. Others had queried the matter.

- RESOLVED: 1. That the Executive's decision regarding fines be endorsed and that the Clubs who had not yet made payment be reminded that until payment was made, their club was banned from taking part in water polo competition. Also that if payment was not received by 30th September, consideration be given to taking further action against the clubs in question.
 - That the system of entry forms for Water Polo contests, showing the players' names and competitive numbers be reintroduced.

Appeals

- (a) The appeal by Dunfermline WPC against the decision of the Water Polo Committee had been dismissed by the Appeals Committee.
- (b) The appeal by Mr. A. Devlin against his suspension imposed by the Water Polo Committee had been dismissed by the Appeals Committee.

4. Tenancy: Director of Swimming's Office

The University proposed that the Association have the free tenancy of the Director of Swimming's office and that in return, instead of the Association providing the services of the Director of Swimming to coach the University Swim Team, they come to a financial agreement with the coach of Stirling A.S.C. to coach the University team.

5. Protest: National Championships

Carnegie S.C. had protested that their swimmer, Paul Smith was denied the honour of being Scottish National Junior Champion for the 200m I.M., due to a break of the rules of the competition. The programme for the Championships had stated that Consolation Finals would be held only if 20 or more swimmers took part in an event, where, in fact, Consolation Finals had been held for events with 16 or more swimmers. Paul had been unaware that his event was to have a Consolation Final and had left the Championships convinced that his heat time made him the Junior Champion.

RESOLVED: That the protest be rejected on the grounds that adequate notice was given throughout the Championships of the alteration to the meet conditions.

6. International Permits

RESOLVED: That the following Permits, issued since the last meeting, be approved:

(ii) Midland District members raised several queries regarding membership of the Water Polo Committee and the rights of those attending meetings, to vote.

RESOLVED: That their queries be raised direct with the Water Polo Convener.

- (b) Report of Convener dated August. Arising therefrom:
 - Council congratulated the Scottish players selected for the G.B. Junior Team in Tenerife.
- (c) Letter from East District: 6 Nations U21 Tournament
 - (i) An explanation was requested as to why the selected players had not received notification of selection in writing. One Club knew no details of the team and would have protested at the non-inclusion of one of their players.

The Director of Administration accepted full responsibility

for not sending out selection letters and apologised. He had been under the impression that the team had been notified verbally of selection and full details for this home international.

(ii) East District members criticised the presentation of medals at the Tournament to team captains only. Members understood this had been done due to lack of support from water polo officials in running the tournament.

RESOLVED: That in future, medals be presented to each member of teams.

Arising from this, members considered the lack of organisation for the Tournament.

RESOLVED: That the Convener be notified that in future, the organisation of events be done in liaison with the office.

RESOLVED: That the Report of the Water Polo Convener be accepted.

Swimming Committee
