32/85 PRESIDENT'S ADDRESS

Before the business of the Meeting began, the President welcomed all members of the Council to the first meeting after the AGM. He especially welcomed the 5 new members and hoped that they would enjoy their period of office. He asked Norrie Beattie, Mrs McLeod-Bain, Mr D Phinn, Dr D Hoare and Mr Angus to accept their badges of office.

Since the AGM he had been very busy. The highlights were the 4 Nations Youth International, which was an outstanding meet from all angles. The East District Championships, East Kilbride Meet, Edinburgh Spring Meet, East and West District Meetings. The President thanked the East and West Districts for their hospitality. He had also attended opening of the Easter Swim School at DCPE and the GB Committee at Preston as a substitute. The Executive had met on three or four occasions, mainly in connection with the Staff situation.

He then gave his thoughts on the duty of the Council - these were: "It acted on behalf of the Association which was the Governing Body for Swimming in Scotland. We are here to serve the best interests of the whole Association which might at times mean making decisions not to everyone's liking. Our duty was to lock at the whole of Scotland and to act as a whole. The Directors. unile not members of the Council were there to give their specialist advice when required." He asked the members to bear in mind that they were there for the benefit of "swimming and swimmers" and this phrase included all disciplines of the sport.

34/85 SUB-NATIONAL FACILITIES (Previous Minute 10/85)

A letter dated 21 March from Paisley ASC putting forward under "The provision of Sub-National Facilities" a request that the Scottish Sports Council be requested to consider the provision of Automatic Timing Equipment at the Johnstone Swimming Pool, which the Local Authority were considering improving. The pool had already been designated as the main competitive pool in the district.

37/85 OCL National Open Championships (Previous Minute 14/85)

The Director of Administration reported that:

(a) OCL had paid their sponsorship of £1000 and in addition had paid VAT of £150, and were providing Programme and Result covers. (b) The RCP was only available on Saturday 20 July until 2.60pm, and therefore we had asked for the use of the Pool from 2.00pm on Tuesday 16 July and all day on 17, 18 and 19.

The question of the availability of Technical Officials for these Championships was raised and the District Secretaries agreed to raise this matter at their next District Meetings.

A letter dated 2 April from the East District was considered, complaining about the requirement that swimmers selected for the 4 Nations Youth International had to attend a training weekend on the 16/17 March. This coincided with the East District Championsnios which Gary Watson of FINS had wished to compete in, but the Director of Swimming had indicated he must attend the training weekend if he wished to swim in the 4 Nations Youth International.

The Club contended that this requirement had not always been strictly applied in the past.

59/85 PRESIDENTS CHAIN OF OFFICE

A letter dated 9 April from Mr L W Turberville on behalf of the Association of Past Presidents of the SASA regarding the Presidents Chain of Office. This provided a record of the Presidents from 1888 until 1979, except for 1905 and 1906 and also the war years. The 1950 link had become detached and was not included in the Chain nor were there links for the years 1980 to the present.

One of the Past Presidents had offered to provide a new Chain of Office to coincide with the start of the Association's second century. They also asked if the Council would agree to supplying the 8 additional links for the present Chain to complete the first century, and also incorporate the missing link. They suggested also that possibly a list of Past Presidents might be included in the Association's Handbook.

RESOLVED: That: the offer of a new chain be accepted with thanks and also we authorised the addition of the 8 links to the Chain.
