

SWIMMING COMMITTEE : DRAFT OF PROPOSED CHANGE TO RULE 56.

" 56. Inter-District Speed Swimming Contests  
(Incorporating the Red Cross Trophy)

(1) Contests are :-

- (a) Kemsley Trophy for swimmers of 15 years and over ;
- (b) An Tostal Trophy for swimmers of 13/14 years ;
- (c) Runciman Trophy for swimmers of 12 years and under.

Note : Swimming year calculated as age at 31st December of the year of competition.

(2) Participation :-

- (a) Each District will take part in these contests ;
- (b) The North and Midland Districts may enter a joint team, upon the recommendation of the appropriate discipline SASA Standing Committee, and subject to the approval of Council.

(3) Organisation :-

- (a) Council shall invite a District to hold the events on behalf of the SASA.
- (b) The SASA will pay for pool hire, medals and officials' expenses. Districts shall submit travel arrangements and estimated travel costs to the General Treasurer at least fourteen (14) days prior to the contest for Executive approval. The known costs will be submitted to the General Treasurer after the contest and will be pooled and shared equally by all Districts. Assembly costs within each District shall be the responsibility of the District.
- (c) The organising District must give District Secretaries at least one month's notice in writing of the venue and arrangements ; the dates of the contests shall be arranged by the Swimming Committee and shall appear in the National Calendar.
- (d) The event shall be held on a Saturday unless with the written consent of the other Districts another day is suitable.
- (e) Districts shall submit names of team members at least fourteen (14) days prior to the contest to the General Secretary clearly indicating the event(s) for which each swimmer is selected.
- (f) The programme of events shall allocate lanes to District Teams on a rotational basis throughout the contest, that rotation being based on a cycle of events (eg 12 and under boys/girls, 13/14 boys/girls, 15 and over men/women, rotation of lane etc).
- (g) Depending on the number of teams entered, the contests shall be arranged as follows :-
  - ( i ) 3 Teams (combination of North and Midland)  
In one heat per event with two swimmers counting for each District, with initial allocation of lanes by a draw conducted by the General Secretary.
  - (ii) 4 Teams  
In two heats per event with the 'B' swimmers swimming in the first heat and the 'A' swimmers in the second heat ; both heats counting for points.

(4) Team Selection :-

- (a) Competitors may swim in one category only, either in their own age group or in a higher age group.
- (b) Competitors may swim in a maximum of three individual events and in the relays.
- (c) Two additional swimmers may be selected for relay events in each section.
- (d) The SASA will grant selected swimmers a District costume badge, the cost of which shall be borne by the District.

(6) Calculation of Results

- (a) In the case of 3 Teams competing each with two swimmers eligible to swim in each event, the points shall be calculated as : 1st = 6 points, 2nd = 5 points, 3rd = 4 points, 4th = 3 points, 5th = 2 points, 6th = 1 point.
- (b) In the case of 4 Teams competing each with two swimmers eligible to swim in each event, the points shall be calculated as follows :-  
1st = 8 points, 2nd = 7 points, 3rd = 6 points, 4th = 5 points, 5th = 4 points, 6th = 3 points, 7th = 2 points, 8th = 1 point.
- (c) In the event of a dead heat, swimmers will share the points.
- (d) The team gaining the highest total of points in each contest will be awarded the trophy for that contest.
- (e) The team gaining the highest number of points from the aggregate of all three contests shall be declared the winner overall and shall be awarded the Red Cross Trophy.
- (f) In the event of a tie on points for a trophy the team with the most individual / Relay First Places will be declared the winner. If there is still a tie, then the team with the most Second Places will be declared the winner. Failing resolution of a winner at this stage, third, then fourth places should be calculated and if the result is still not established a draw will be declared.

## Nomination for SASA Awards

I have to advise you that I have sought nominations from the Swimming Committee Members for the Nancy Riach Memorial Medal and for the W.G. Todd Prize and Trophy. The result of that invitation is as follows :-

### W.G. Todd Prize and Trophy

The Swimming Committee proposes that the award be made to Miss Corrine Jack for her outstanding performance for GB at the European Junior Championships held at Dunkirk on 26th/29th July 1990.

Corrine produced two personal best times to finish 7th in the 400m Freestyle in a time of 4.23.88 and 11th in the 200m Freestyle in a time of 2.07.66.

### Nancy Riach Memorial Medal

No formal nomination was received and therefore I am unable to make any formal proposal to Council.

However, in subsequent discussion with some members of the Committee (ie with those who contacted me by telephone last night), there is support for three candidates :-

Miss Jean Hill : for her swimming performances throughout the year and for her promotion of swimming.

Miss Ruth Gilfillan : for her achievements in the Commonwealth Games reaching three finals.

Miss Alison Sheppard : for her GB Short Course Record in the 50m Free.

REPORT on behalf of the SWIMMING COMMITTEE to the SASA COUNCIL MEETING of  
25th November 1990.

1. Business from 14th October 1990

There have been no further meetings of the Swimming Committee since 30th September 1990. The next meeting is scheduled for Sunday 2nd December 1990 at Stirling University.

An 'Information Up-date' was circulated to members of the Swimming Committee on 2nd November. This dealt with the following matters :-

- (1) Correspondence to 2nd November and called for nominations from members for the W.G. Todd Prize and Trophy ;
- (2) Provided a copy of the submission on behalf of Swimming Committee for the 1991 Annual Programme Guide ;
- (3) Circulated a copy of the Meet Programme for the Gilbey's Ulster Games (16/17 March 1991) ;
- (4) Circulated a copy of my Report to Council (14th October).

3. ASFGB Technical Committee

I will be attending the ASA Winter National Championships at Coventry on Saturday and Sunday 17th/18th November with the Selection Meeting on Sunday 18th for the World Championships.

I was grateful to have opportunity to discuss with Mr. Craig (West District) on 9th November some aspects of the arrangements for the above Championships. However, I am concerned that the Swimming Committee is not being advised of other aspects (eg arrangements with TV which might effect the programme).

Report : ASFGB Swimming Technical Committee : TSB Winter National Championships,  
Coventry 15th/18th November 1990.

1. I attended the above Championships on Saturday 17th and Sunday 18th November and the formal Selection Meeting (evening of Sunday 18th November) for the GB Team to compete in the World Championships in Perth, Australia on 8th/13th January 1991.
2. The selection criteria had been set previously by the Swimming Technical Committee and is attached for reference, together with a note of the consideration times.
3. Consideration times were achieved over the three identified Meets as follows :-

The above became 'automatic' selections.

4. The second phase of selection took account of the potential Team Relay rankings in the world and it was identified that the 4 x 100m Medley Relays (Men and Women) would both be ranked inside the consideration times. It was therefore agreed to select the swimmers whose times combined to achieve that level, and the following additional swimmers were selected :-

5. At this point, 15 swimmers had been selected from a theoretical/financial limit of 16. Discussion then centred on the possibility of including one swimmer whose best time within the identified Meets was only 0.117% over the considered time. The problem faced by the Committee was that six other swims were within + 1% of the considered times.  
In view of the advice offered by the Team Manager and Team Coach, I voted not to support the inclusion of any swimmer who had not achieved the consideration time.
6. There were several points of interest and significance arising from attendance at the Meet :-
  - (1) The meet was held in a known 'slow' pool : why ?
  - (2) Water level in the pool was some 6"-8" below the trough : why ?
  - (3) Is it right to combine a National Championships with a GB Trial with so much at stake for the swimmers - would it not have been better to hold a separate Trial at the 'right' time and in the 'right' pool to give the swimmers the best possible chance ?
  - (4) I wonder how many of the swimmers who were within the 1% of the consideration times would have made it if the conditions had been favourable ?
7. Congratulations are due to Rik Leishman on his selection.

WORLD CHAMPIONSHIPS : PERTH, AUSTRALIA : 8TH/13TH JANUARY 1991

SELECTION POLICY

1. The team will be selected from performances at the A.S.A. National Swimming Championships, 26th/29th July 1990, the LEN Open International Cup, Rome 9th/12th August and the A.S.A. Winter Championships, 15th/18th November.
2. Consideration times will be used for individual selections. These are based on the 16th place in the 1989 World Rankings plus January 1990 times on a basis of two swimmers per country.
3. In considering team relay selections, the criteria will be based upon the potential of a team to reach the World Championship final in that event.
4. Pre-selections:
  - Adrian Moorhouse - 100m Breaststroke
  - Nick Gillingham - 200m Breaststroke
5. Additional pre-selections of potential World Championship medallists will be made in late August based on the A.S.A. National Swimming Championships and performance and places achieved in the LEN Open Cup. For this, swimmers must have achieved Consideration Times at one of the aforementioned events.
6. No more than one swimmer per event to be pre-selected.
7. The final selection to be made after the Winter Championships, when performances at all three events will be considered.
8. General Notes on Selection
  - a) Swimmers to be selected on places gained in finals; these to take priority over heat and 'B' final times and placings. 'B' final placings take priority over heat times and placings. This also applies for all relay team selections.
  - b) Times returned in club relays not to be considered.
  - c) Split times (team or individual) not to be considered.
  - d) Should an individual event not have both places filled after the agreed number of competitors have been selected, then additional entries can be made from those already included in the team.
9. All pre-selected swimmers must show their fitness and form by competing in the A.S.A. Winter Championships.
10. Swimmers living and training overseas must comply with this Selection Policy.
11. Training and Travel
  - a) The team will travel to Australia on approximately 17th December 1990 for a training camp and will move into Perth on 27th December for final preparation. Return home on 14th January 1991.
  - b) All selected team members must attend the training camp.
