Dear Bill,

The Swimming Committee, at their meeting of 26th May, asked me to write to you as a matter of some urgency to express to the SASA Executive/Emergency Committee their growing concern that the existing structure of posts, duties and responsibilities within the Association is proving to be inadequate and increasingly inappropriate to meet current requirements and future objectives.

Although discussion in the Committee was primed by the events surrounding the recent World Cup Final and the role of the Director of Swimming at that event, the issues which emerged were much broader; the Committee attempted to adopt a positive approach and to assess current and future requirements from the existing situation. On behalf of the Swimming Committee, I trust that the Executive/Emergency Committee will view the following points in that same light:

- (1) Swimming (Technical) Leadership
 In the view of the Swimming Committee, there is a clear need for the Wave Programme to have 'hands-on' leadership of a swimming technical/chief coach nature.

 Such leadership cannot be provided on an occasional basis the swimmers involved are our best 'senior' swimmers who need and deserve the best service and assistance which we can provide. If we can provide for them we are sure that the Association and Scottish Swimming will benefit from them in the longer-term.
- (2) Grass Roots Development
 The Committee is also concerned to see the development of a strategy and action to nourish the grass roots of Scottish Swimming the club and community activities within the Districts.
 We have no immediate or easy solutions to offer. There are examples which the Association might wish to consider such as the SRU initiative of appointing Regional Development Officers (SASA District Development Officers?).
- The Swimming Committee is concerned that the Association seeks to provide for high level swimming technical expertise, for grass roots development, for input into Synchronised Swimming, Water Polo and Diving together with technical administrative support all from one post.

 The Committee is deeply concerned that such diverse and demanding role are expected to yield significant results from any one man or woman.
- (4) Technical Assistant/Administrator

(4) Technical Assistant/Administrator

The Swimming Committee acknowledges that the current situation in respect of the SASA Office is unfortunate and we are very grateful to Mr. Charles for his hard work and willing assistance on numerous matters.

However, there have been many recent examples to support the view of the Swimming Committee that there is urgent need for the provision of technical administrative support based in the SASA Office. While there is undoubtedly an argument to identify technical administrat support and expertise with the relevant discipline committee and with the appointed conveners of those committees there are equally valid arguments which severely constrain their effectiveness. As Convener of the Swimming Committee, I have attempted to service the main administration requirements of that Committee and to retain as much personal contact as possible. However, I cannot leave work and go to the Office to deal with problems or travel to every committee/ working group which would ideally be attended. There is a clear need for a technical administrator who would attend discipline committee meetings, learn the background to the policy decisions taken at those meetings and, in conjunction with the convener, ensure that the appropriate actions are taken at the Office.

(5) SASA Structure

The Swirming Committee is also concerned to see the development of the revised Committee structure of the Association along the lines suggested at the A.G.M. in February 1991.

While such changes are for the delegates to decide in February 1992 there is concern on the part of the Swimming Committee that input of their views to the key policy-making body of the Association and feed-back from that body are both distant and delayed.

(6) Timing of Considerations

The Swimming Committee requested that these matters be given consideration on the first possible occasion and noted that the Director of Swimming expressed his willingness to negotiate with the Association on those matters which touch on his current post.



World Cup Final : Canada

The Swimming Committee considered the contents of your letter of 22nd April at their meeting of 26th May. The Committee sought explanations for the matters identified and I have summarised the outcomes as follows:

Selection

It is acknowledged that Alison did not receive notification of selection by letter. However, the Committee was advised that Alison and others had been advised of potential selection at the Milan/Bonn meets and they received confirmation of selection at Sheffield.

The Committee is also aware of other circumstances which placed the whole venture to Canada into question until two days before departure - no one person can be held responsible for that situation.

Therefore, under the circumstances, the Committee and the Association can only apologise for the fact that normal selection procedures were not followed.

Travel/Accommodation

- a) For reasons noted above, it is recognised that travel arrangements were notified late;
- (b) The Committee was advised that the Director of Swimming informed the c) swimmers at Gatwick Airport of their hotel accommodation (first night) and of the other travel arrangements. Swimmers had opportunity to telephone to parents and advise them of that information if necessary. The Committee noted that there are many occasions when Teams cannot be given, in advance, details of accommodation.

 The Committee was advised that the SASA Office knew of the contact number in case of emergency.

Appointment of Coach

The Swimming Committee is conscious of the issues raised in your letter under this heading. However, because the Swimming Committee has already formally raised these issues with Mr. Black (General Secretary) it would not be appropriate to deal with these matters in detail. The simple answers to your two specific questions are as follows:

a) There was no indecision on the part of the Swimming Committee - indeed, a positive recommendation was made, for good reason, that the Director of Swimming should be coach/team manager.

b) As far as I am aware, the Swimming Committee did not apply any pressure,

pressure/ on Alex McNeil; unfortunately, at the time these issues arose I was away on holiday.

Coaches Responsibility

The Committee gave long and careful consideration to this matter. On one hand, Mr. Smith accompanied the swimmers to the departure lounge for their flight to Gatwick; the swimmers were all of an age where they should be capable of behaving responsibly; and all the swimmers were relatively experienced travellers.

On the other hand, the Committee took the view that the Association and the parents should have been aware of the arrangements prior to departure from the UK.

Taking overall account of the situation, the Committee has recommended the following guidelines for future travel arrangements:-

(1) That the Team Manager/Coach should under normal circumstances

travel with the Team ;

(2) That any exception should have the prior approval of Swimming Committee or be the result of an emergency situation.

Performance/Communication

The Committee is likewise pleased to note the good performances of the swimmers and feels that the correct swimming (technical) decisions were made.

As Convener of the Swimming Committee I have tried hard to ensure that the business of that Committee is 'open' as far as possible and practical. In that context the Committee is grateful to you for bringing these matters to our attention; where we have been able to take positive action we have done so ; unfortunately, as indicated previously, the Committee is bound to deal with some matters on an internal basis within the Association.

Travel Insurance

Although not specifically considered by the Committee, I can advise you that I have subsequently been assured by the Director of Swigming that our normal travel insurance cover was valid for the Meet.

Cumbernauld International Swim Meet 8, 9, 10 November 1991

Further to the discussion at the Swimming Committee meeting, on Sunday, 26 May 1991 in Edinburgh, I now write to confirm my offer which I hope will be given serious consideration by the Association.

- 1. The Association be allowed to invite foreign National Team swimmers to the Cumbernauld International Swim Meet.
- 2. The Association will pay for accommodation for countries and numbers, to be determined by agreement with the Meet Director.
- 3. The Meet Director will deal with all other administration, such as booking of accommodation, transport to and from airport, hotel and pool.
- 4. Executive members and the Swimming Committee Convenor, plus all foreign swimmers and coaches will be invited to the Civic Reception hosted by the Provost.
- 5. Information packs including entry forms will be provided to the Association for sending to foreign National Teams.
- 6. Foreign teams to arrange and pay for own travel arrangements to Glasgow Airport.

7. The Meet Director will reserve the right to invite other International Swimmers if this is felt to be necessary.

I believe that this joint initiative will be in the best interest of both the Swimming Association and the Cumbernauld Meet. It will permit the Association to fulfil what I believe to be an obligation to reciprocate the hospitality of invitations received from many other Swimming Associations for many years.

I am not convinced that it is appropriate to invite these teams to our National Championships as the position could become farcical if their standard was much higher or their numbers too great.

Finally, can I request that this matter be treated with urgency as such invitations should now be given out as soon as possible.
