Need for sponsorship recognised if we are to offer to host the event in 1993; Swimming Committee recommends to Council that attempts should be made to obtain sponsorship but that the decisions need to be made by December 1991; we will have to advise nations in advance of the 1992 LEN Calendar Conference.

1. Minutes of the Meeting of 16th June 1991

The Minutes of the Meeting of 16th June were approved without amendment on a motion proposed by Mr. Dashwood-Brady and seconded by Mr. Davidson.

2. Matters Arising

The following matters were raised from the Minutes of the Meeting of 16th June :-

Page 1: Item 2 (ASFGB Selections)

The Convener and the Director of Swimming apologised for not informing District Conveners immediately of the GB selections: that omission had subsequently been corrected through the Correspondence list, Item 91.298. It was noted that the question of eligibility of Hiroshi Ikeda had not been fully tested; however, had he been the fastest swimmer then the matter of eligibility might have been determined by his passport. It was also noted that the Convener had again received comment from Mr. G. Robb (Press) regarding the lack of uniformity in the issue of selection information to the Press.

Page 2: Edinburgh District Council

It was noted that there was nothing further to report on this matter.

Page 2: World Cup Final Report

The Convener noted that he had still not received the Report for this event. The Director of Swimming undertook to ensure that the Report is circulated.

ACTION: DIRECTOR OF SWIMMING

Page 2: Recommendations to SASA Emergency Committee

The Convener confirmed that he had not received any formal response to his submission on behalf of the Swimming Committee. Any information obtained had been the result of a brief telephone discussion with Mr. Black. Subsequently, as a result of discussion with the President, it was now probable that the 'working group' would not meet in July as anticipated earlier.

Page 3: Finance

It was noted that it is proving difficult for the Treasurer and the Convener to arrange a date to deal with several financial matters; however, this will be arranged at the earliest date possible.

Page 3: Domestic Programme (b)

Great concern was expressed in connection with the letter received from Barrhead Dolphins. That concern rested on two main points:-

(a) Confidentiality

That elements of the Swimming Committe discussion relating to individuals had clearly been transmitted outside the Committee. While it is the stated wish of the Convener to ensure that discussion within the Committee is open and reported as widely as possible, members are asked to be sensitive and careful with any matters which involve individuals.

(b) Accuracy

It was considered by the Committee that some of the points contained in the letter from Barrhead Dolphins did not accurately reflect the discussions. Therefore the accuracy of the 'reporting' to representatives of Barrhead Dolphins was questioned.

The Meeting noted the reply sent to Barrhead Dolphins by the Convener and homologated that action.

The Meeting also noted and approved the addition of Mrs. Eileen Adams and Mr. Jim Park to the list of coaches attending the ASA National Championships.

3. Correspondence

The following items of Correspondence were considered :-

91.298: Mr. Smith (Director of Swimming) advised the Meeting that he had been involved in considerable discussion and difficulty over the provision of GB Team Kit for the Youth Olympics event in Spain. Even allowing for the relatively short notice for the Contest (ie to ASFGB from the ASA) it should have been possible to ensure that sufficient kit to provide team identity is provided.

It was agreed that SASA representatives to the GB Committee should be asked to add weight to the views of the Swimming Committee (SASA) that the Team should have as much kit as possible under the circumstances.

- 91.308: The letter from Mr. Raeburn was read and noted. The Committee agreed to note the proposed dates of the Schools event (first week July 1992) but noted the following problems:
 - a) That the Committee could not accept any proposal to contribute SASA Swimming Committee allocations to support a Schools event;
 - b) That a recent decision by the ASA to hold their Olympic Trials on 21st/24th May and their Championships on 11th-14th June presented problems for the timing of our Championships (Age Group and Open) with the possibility of our Open Championships having to move into the first weekend of July.
 - c) Previous experience with Schools Internationals (eg Brugges) had not been considered to have been in the best interests of the swimmers.

Mr. White agreed to undertake to obtain more information on the Meet and the proposals of the Scottish Schools Swimming Association.

- 91.311: The Committee noted that Jennifer Lochray had been under medical advice in respect of a recent illness.
- 91.312: The Committee also noted that Elaine Grubb had suffered as a result of an accident and the medical treatment had hindered her preparations for the National Age Group Championships.

4. National Squad Selections/

6. National Squad Staffing

Proposals from the Director of Swimming were considered by the Committee and the decisions taken are recorded in the attached appendices.

5. Wave Programme / Commonwealth Games Squad Selections

It was agreed that these selections should be held over until the results from the GB International Events and the ASA Championships are known.

7. A.O.C.B.

a) Inter-District Contest 1991

It was agreed to recommend to SASA Council that the format of the 1991 Contest be amended to one contest in each age-group and one overall contest with two swimmers from each District counting in each event (Mrs. Cochran confirmed that North and Midlands will swim combined).

b) National Age Group Championships 1991

Several points were raised in connection with the above event :-

- i) Mr. Phillips expressed dissatisfaction with the late (2 days prior to the event) notification of accepted entries.
- ii) The major problem over the processing of entries is that the Association does not have the computer facilities, the programmes or the staffing until these matters are rectified, we will always be dependent on the goodwill and amateur input of members to whom we are indebted.
- iii) Members of the Committee felt strongly that we should not move to advance the date of entries that would not be in the best interests of the swimmers.

- iv) A potential solution was noted: to create 'qualifying times' and to undertake to accept all entries within those times. Such a solution would require safety/control mechanisms such as required proof of entry times in the event of failure to achieve the time at the Age Group Championships and the imposition of severe fines in the event of failure to substantiate the entry time.
- v) However, the best option in the view of the Committee is the provision of equipment and staffing at the SASA Office to service the requirements at present.
- vi) Mr. White noted the improvement in the number of entries at 17/18 and 19/24 (Men) and asked that consideration be given to splitting the heats in those age groups.
- vii) Mrs. Smith noted that only one Session (Sunday, am) was oversubscribed and that all the other sessions ran to time.
- viii) Mr. Charles noted that a new representative of ESSO Youth Sport had questioned the award of the ESSO Trophies for Best Performance to the 19/24 Age Groups. The Committee agreed to respect the views of ESSO on this matter and to recommend to Council that the eligibility for the award of these Trophies be restricted to 17/18 years and under.

8. Date of Next Meeting

It was agreed that the next Meeting of the Swimming Committee would be held on Friday 30th August at 4.00 pm at Cramond Campus (DCPE) of Moray House College. An evening meal will be provided and accommodation will be available as required in connection with the Seminar due to be held on Saturday 31st August (National Squad Staff) and the SSCA on Sunday 1st September.

The Business of the next Meeting of the Swimming Committee will concentrate on the following:-

- a) Selections (Wave/Commonwealth Games Squads including times achieved in July and August)
- b) Domestic matters (structure of age groups etc; calendar of events 1992)

 (NOTE: In that connection, District Conveners are asked to provide as much information as possible on the intentions of their Districts.)
- c) Squad Training arrangements
