

Services of the Scottish ASA Director of Swimming

At the SASA Council Meeting on the 18th January, 1992 a request from the Secretary of the Great Britain Technical Swimming Committee asking for the services of the SASA Director of Swimming to assist with the organising of the GB Olympic Trials was discussed and considered at great length and it was rejected for the following reasons:

i) Time required: 12 days prior to the event and then the five days of the trials on

top was considered excessive.

ii) His involvement means additional expense in terms of travel and accommodation costs. The original agreement with the Great Britain Treasurer was an allocation of £5000 plus £2500 expenses this was reduced to £6000 last year. The salary element was intended to pay for employing someone to do the work of the Director in his absence. This has not happened.

iii) The Director had explained to the Scottish Sports Council that he had been unable to submit reports to them because he was already overworked and was

working 100 hours per week.

iv) The Director had already been absent from the SASA Headquarters for two and a half weeks in January, there was a priority requirement for his technical output and direction in the administration of the Association.

v) Council had already agreed to his request to attend the normal GBTSC

meetings.

vi) The Director has alredy taken on commitments with six outside agencies ranging from the UK Sports Council to SCOTVEC the Scottish Examining body for SNVQs.

Meeting with the SASA Swimming Committee: 9th February 1992

Thank you for coming to our Swimming Committee Meeting on Sunday 9th February - members found it helpful to have several matters clarified. As agreed, I will report to the AGM on 29th February in respect of the progress on the Research Project.

Members had opportunity later on Sunday 9th to consider the issues raised under the heading of Schools' International Swimming. Although sympathetic to the principle of joint ventures between our Associations, the Committee noted the following points:-

(i) That to agree to your proposal of International competition this summer would be to establish a precedent of donating SASA funding to another body - a precedent which members felt unable to support.

(ii) That essential to any joint venture is that it is part of an integrated strategy for the benefit of swimmers who are operating within the SASA programmes of training and competition including selection and management arrangements - clearly, your proposal does not 'fit' within that requiremen

(iii) That the dates of the proposed Meet clash with those of our National Championships and could well have a distorting effect on Club awards and Coach awards based on those Championships.

iv) That although the dates of our National Championships may have to be changed, such change cannot be defined within your required timescale.

I must therefore advise you that we are unable to co-operate with your proposal on this occasion. However, I hope that we can continue discussions on the matter of a longer-term strategy and on the planning and management of any positive outcomes.

SASA Swimming Committee Meeting of 9th February 1992

As indicated in my letter of 1st February, your letter of 25th January 1992 was considered by the SASA Swimming Committee at their Meeting of 9th February. I have been asked by the Committee to thank you for your letter of explanation.

The Committee has accepted your explanation regarding the events leading to the publication of the articles in the Press - we too regret that a sixteen year old is put under pressure to respond to a telephone call from the Press. No action will be taken.

The Committee also investigated the background to Angela's non-selection arising from the fact that she did not swim at the National Sprint or SASA National Winter Championships. We were advised by the Director of Swimming that your wife's telephone call to him related only to the Sprint Championships and that he had expected Angela to enter our Winter Championships. When the Committee met in December, no explanation for non-attendance at the Winter Championships was available and therefore Angela (along with others in the same situation) was not selected in line with the published criteria. On this point, I suggest that in future you write directly to me as Convener to give advance warning of any potential problems.

Finally, the Committee has asked me to emphasise that such situations carry no longer-term implications: for example, attendance and performance at the East Kilbride Meet will render Angela eligible for consideration for selection for the 8 Nations Contest in Finland in April.

In respect of your more recent telephone call, please assure Angela that her performances are noted and highly regarded in Scotland - I attach a copy of the

Following the SASA National Winter Championships held at Ayr in December 1991, you were selected to represent Scotland in the 1992 Ulster Games.

In view of the escalating violence at that time the SASA Swimming Committee decided to hold that selection 'on ice' to allow the maximum possible time for matters in Ulster to settle.

The Swimming Committee met again on 9th February to make a final decision and we have to inform you, with considerable regret, that it was the unanimous view of the Committee that Scotland should withdraw from the Games in the interests of the safety of the Team. That regret is expressed only in respect of your selection and of the situation faced by our swimming colleagues in Ulster.

At this time unable to offer any promise of a substitute selection this season however the Committee will review the situation in March.
