**CTP1.0 General**

CTP1.1 The Scottish Coaches Technical Panel Committee, a National Committee of Scottish Swimming, shall comply with the relevant sub-sections of Company Article A3.1.3.

CTP1.2 The membership of the Coaches Technical Panel Committee shall be in accordance with Company Article A3.1.3.8.2. See CTP2 for details of selection criteria.

CTP1.3 The Coaches Technical Panel (CTP) shall have the following responsibilities in addition to those stated in Company Article A3.1.3.6.1.

CTP1.3.1 To provide feedback on performance related matters focussing primarily on the following core areas.

- a) Calendar Planning
- b) Selection Policy Review and Development
- c) National Programme Content
- d) Post-event feedback
- e) New performance idea feedback
- f) Institute Network Service Provision feedback
- g) On-going performance review

**CTP2.0 Selection Criteria**

CTP2.0.1 The membership of the CTP committee is subject to the following selection criteria.

CTP2.1 Coaches Reflecting Geographical Spread of Programmes Around the Country.

CTP2.1.1 Four coaches will be selected based on numbers of swimmers within the National Programme (Youth Development Squad and above).

CTP2.2 Coaches Nominated by the Performance Director

CTP2.2.1 Two additional coaches are to be selected on to the panel to ensure that:-

- a) There is representation from all areas of the country.
- b) The CTP contains a range of coaches covering grass roots to performance.
- c) The CTP contains coaches with a range of viewpoints, philosophies and experience.
- d) The coaches on the CTP are able to fully commit to being part of the panel.

CTP2.3 Additional Coaches Invited to Meetings

CTP2.3.1 Two additional coaches will be invited to each meeting in order to bring added input from the local coaching community and increase communication/involvement of coaches in different parts of the country.

CTP2.3.2 The additional coaches will be invited by the Performance Director and coaches may be invited on more than one occasion but normally no more than twice in any swimming year.

**CTP3.0 Liaison**

CTP3.1 National Swimming Committee

CTP3.1.1 The CTP will liaise with National Swimming Committee on

- a) Calendar planning of District and Club competitions in conjunction with the National Championships / Meet Plan.
- b) The selection of Staff and Competitors eligible to compete outwith Scotland or in International contests held in Scotland.

CTP3.2 National Open Water Committee

CTP3.2.1 The CTP will liaise with National Open Water Committee on

- a) The selection of Competitors eligible to compete outwith Scotland or in International contests held in Scotland.

**CTP4.0 Meetings**

CTP4.1 The CTP meetings will be rotated round the country in order to promote participation from the whole of the Scottish Swimming coaching community.

The rotation will normally be:-

- a) Stirling
- b) North
- c) Stirling
- d) East
- e) Stirling
- f) Midlands
- g) Stirling
