SS1.0 General

- SS1.1 The Scottish Synchronised Swimming Committee (SSSC), a National Discipline Committee of Scottish Swimming shall comply with the relevant sub-sections of Company Article A3.1.3.
- SS1.2 The SSSC shall conduct its business in accordance with A3.1.3.2 of the Company Articles
- SS1.3 Wellbeing and Protection
All rules and regulations regarding wellbeing and protection will be observed in accordance with Scottish Swimming requirements and guidance.
- SS1.4 Membership of the SSSC shall be in accordance with Company Article A3.1.3.7.1.
- SS1.5 The SSSC shall have the following responsibilities in addition to those stated in Company Article A3.1.3.6.1.
- SS1.5.1 Draft and formulate Regulations for Artistic Swimming activities held in Scotland;
 - SS1.5.2 Decide on the interpretation of the Regulations pertaining to Artistic Swimming and give rulings there on;
 - SS1.5.3 Compile and submit for Company Board of Directors approval a calendar of events for International, National Meets and Contests and District Championship Events;
 - SS1.5.4 Conduct Artistic Swimming Championships;
 - SS1.5.5 Arrange lectures and conduct examinations of Artistic Swimming teachers and judges certificates;
 - SS1.5.6 Select competitors eligible to compete out with Scotland or in International contests held in Scotland;
 - SS1.5.7 Appoint all necessary officials for Artistic Swimming events.
- SS1.6 Eligibility to compete is as defined in Company Rule R4.5.
- SS1.7 The SSSC shall appoint or arrange for the appointment of a Jury of Appeal in advance of each Championship / Meet. The procedure and treatment will be in accordance with Company Rules R11.3 and R11.4.
- SS1.8 The Company on receipt of information from SSSC shall issue an Annual Meet Information Pack for all National competitions to all Districts and Synchronised Swimming Clubs by 1st August each year. In addition the pack will be issued to District Synchronised Swimming Conveners or the District Secretary (if there is no Convener).
- SS1.9 The Scottish Swimming Governance documents will apply with regard to:-
- a) Championships and Meets (C8.2.1 and R4.0)
 - b) Trophies (R10)
 - c) Eligibility (R4.5)
 - d) Fees (R3.4)
 - e) Protests (R11)
 - f) Complaints & Appeals (R12 - R15)
 - g) Suspensions and Fines (R13.10 & R13.11)
 - h) Clearance (R5.2 Change of 1st or 2nd Claim Club)

SS2.0 Championship Conditions**SS2.1 Management**

- SS2.1.1 The management of Championships shall be the responsibility of the SSSC who may appoint an Organisation Sub-Committee.

SS2.2 Competitions

- SS2.2.1 Competitions shall consist of any combination of the following sessions.
- SS2.2.1.1 Figure Competition - Each competitor must perform the required number of figures. The number and name of the figures will be as published in the Meet Information Pack.
 - SS2.2.1.2 Technical Routine - Each Solo, Duet and Team Routine must perform the required elements as published in the Meet Information Pack.
 - SS2.2.1.3 Free Routine – Each Solo, Duet, Trio and Team must perform the Free Routine, which may consist of any FINA listed figures, strokes and / or parts thereof to music. Free Routines are those having no restrictions as to choice of music, content or choreography.
 - SS2.2.1.4 In the mixed duet, entries must be for one male and one female.

- SS2.2.1.5 Free Combination Team - Free Combinations has a maximum of ten (10) competitors who make a combination of routines (Solos, Duets, Trios, Teams). At least two (2) parts must have fewer than three (3) competitors and at least two (2) parts must have four (4) to ten (10) competitors. Start of the first part of the routine may be on the deck or in the water. All of the following parts must start in the water. A new part begins in very close proximity to the previous part.
- SS2.3 Penalties in Figure Session**
- SS2.3.1 Penalties in Figure Session as FINA Rule AS11

- SS2.7 Final Result**
- SS2.7.1 Calculation of the Final Result as FINA Rule AS20
- SS2.8 Time Limits for Routines**
- SS2.8.1 Time limits for Technical Routines and Free Routines will be published in the Meet Information Pack. These time limits include ten (10) seconds for deck movements.
- SS2.8.2 There shall be an allowance of fifteen (15) seconds less or plus the allotted time for Technical Routines and Free Routines.
- SS2.8.3 The walk on for the athletes from the designated starting point to the achievement of a stationary position(s) may not exceed 30 seconds. Timing shall commence when the first competitor passes the starting point and end when the last competitor becomes stationary.
- SS2.8.4 In routine events, when the Routine starts in the water, the time allowance for the athletes to achieve a stationery starting position in the water shall not exceed 30 seconds. Timing shall commence when the first competitor moves past the starting point and end when the last competitor assumes a starting position.
- SS2.8.5 Timing of the routine shall start and finish with the accompaniment. Timing of the deck movements shall end as the last competitor leaves the deck. Routines may start on the deck or in the water, but they must finish in the water.
- SS2.9 Team Routine**
- SS2.9.1 A team routine shall consist of at least four (4) but not more than eight (8) Competitors (for exceptions, see SS 6.2). The number of team Competitors may not change between Technical and Free Routines.
- SS2.9.2 Free Combination Conditions
- Free Combinations has a maximum of ten (10) competitors who make a combination of routines (Solos, Duets, Trios, Teams). At Least two (2) parts must have fewer than three (3) competitors and at least two (2) parts must have four (4) to ten (10) competitors. Start of the first part of the routine may be on the deck or in the water. All of the following parts must start in the water. A new part begins in very close proximity to the previous part.
- SS2.10 Pool Requirements**
- SS2.10.1 Consideration must be given to the depth and width of the pool according to the level of competition.
- SS2.11 Entries & Withdrawals**
- SS2.11.1 Entries must be made on the standard application form available from the Company and returned completed, accompanied by the appropriate fee, not later than 28 days before the start of the event. Entry details may be changed upon consultation with the Referee up to 24 hours before the event.
- SS2.11.2 Competitors withdrawing from National events will be fined as per the Discipline fees in the Scottish Swimming Information Guide.
- If the withdrawal is due to medical reasons the swimmer must produce documentary proof of the medical condition.

SS2.12 Draw – Order of Appearance

SS2.12.1 The draw for the order of appearance shall be made by the SSSC Convener or an Official appointed for this purpose 7 days after the receipt of entry forms.

SS2.13 Technical Officials

SS2.13.1 Technical Officials appointed by the SSSC shall consist of:

- a) Referee
- b) An Assistant Referee for each additional panel of judges
- c) A Chief Recorder
- d) Each panel of judges shall consist of five (5) or seven (7) judges.
In Routines two panels of judges may be used.
In Free Routine sessions, three panels of judges will officiate, one panel will judge Execution, one panel will judge Artistic Impression and one panel will judge Difficulty.
- e) In Technical Routine sessions, three panels of judges must officiate, one panel shall judge Execution, one panel shall judge Impression and one panel will judge Elements.

SS2.13.2 For each figure panel – a clerk of the course, two scorers (one of whom will be the recorder) and a caller will be required

SS2.13.3 For routines – Three timekeepers, a clerk of course, two scorers and a number of runners will be required.

SS2.13.4 Controller of music and underwater speakers, Meet Secretary, Announcer and other officials as may be necessary

SS2.14 Technical Officials Training

SS2.14.1 The SSSC shall arrange for the training / retraining and examination of teachers and technical officials in accordance with sub-paragraph SS1.4.5.

SS2.14.2 Candidates for training and examinations must be 16 years of age and registered with Scottish Swimming prior to commencing training.

SS2.14.3 Workshops will be arranged after which an examination will be held in conjunction with other disciplines.

SS2.14.4 The SSSC will be responsible for maintaining a list of all qualified Officials.

SS2.15 Expenses

SS2.15.1 All claims for expenses shall be made on the official forms in accordance with Company Rule R3.7 and shall be submitted, countersigned by the discipline budget holder, to the Company.

SS2.16 Videos

SS2.16.1 All Figures/Elements, Technical and Combination Routines will be video recorded. It is the Referees responsibility to ensure that these videos are deleted after the event.

SS3.0 Artistic Swimming Club Championships (Mary Black Rosebowl)**SS3.1 General**

SS3.1.1 This competition is open to all affiliated clubs in Scotland and shall be held on a date to be decided by the SSSC.

SS3.1.2 There is no figure section in this competition.

SS3.1.3 Swimmers may enter in one Combination team and one Free Team.

SS3.1.4 All details of Routines and Times will be published in the Meet Information Pack

SS3.2 Awards

SS3.2.1 Individual Awards

An award will be made for the 1st, 2nd and 3rd in each Event.

SS3.2.2 Club Awards

The Mary Black Rosebowl will be awarded to the Club with the highest number of Points. In the event of a tie for the Mary Black Rosebowl, the club with the most 1st places in each event shall be awarded the Rosebowl.

SS4.0 Inter District Artistic Swimming Championships**SS4.1 General**

SS4.1.1 A maximum of twelve Competitors per District for each Competition.

SS4.1.2 Competitors must hold a minimum of Grade 2.

SS4.1.3 All competitors must compete in the figure competition.

SS4.1.4 Each District shall pay £50 entry fee for each Competition.

SS4.1.5 All details of Figures, Routines and Times will be published in the Meet Information Pack.

SS4.2 Marking & Awards

- SS4.2.1 The marks gained in each Age Group section (Figures, Solo, Duet, and Free Team) shall be added together for the Championship.
The winning District shall receive the Elizabeth Hamilton Trophy.
- SS4.2.2 Medals shall be awarded as follows:
Gold will be awarded if there are 3 or less competitors in an event.
Gold, Silver and Bronze shall be awarded where there are 4 or more competitors in an event

SS4.3 Expenses

- SS4.3.1 All expenses up to the agreed budget limit shall be borne by Scottish Swimming who shall receive all income. Costs in excess of the agreed limit, shall be borne by each individual District. Assembly costs within each District shall be the responsibility of the District. The Company Board may consider exceptional cases requesting assistance and grant additional expenses. Each District may send up to ten swimmers a coach and a Team Manager for each Championship / Competition.

SS5.0 Scottish National and Open Age Group Artistic Swimming Championships**SS5.1 General**

- SS5.1.1 The Senior Championships in Solo, Duet and Mixed Duet are open to competitors who have passed Grade 5 Bronze or above of the Swim England Award Scheme and are open to members of organisations affiliated to FINA.
- SS5.1.2 The minimum requirement for the Junior Championships is Grade 4 Bronze of the Swim England Award Scheme for National competitors and is open in Solo and Duet to members of organisations affiliated to FINA.
- SS5.1.3 The minimum requirement for the 13, 14 & 15 year age group Championship is Grade 3 Bronze of the Swim England Award Scheme for National competitors and is open in Solo and Duet to members of organisations affiliated to FINA.
- SS5.1.4 The minimum requirement for the 12 and under age group Championship is Grade 2 Bronze of the Swim England Award Scheme for National competitors and is open in Solo and Duet to members of organisations affiliated to FINA.
- SS5.1.5 All details of Figures, Routines and Times will be published in the Meet Information Pack.

SS5.2 Awards

- SS5.2.1 SASA Medals shall be presented as follows:-
a) Open Championship - Gold, Silver and Bronze medals will be presented.
b) National Champion - A Gold Medal will be presented (provided the individual is not also the Open Champion).
- SS5.2.2 Trophies shall also be awarded where applicable.

SS5.3 Trophies

- t) Junior Open Solo Championship - **The Jackie Brayshaw Prize**

- x) Junior Open Free Team Championship

- aa) Open Technical Duet Championship
- bb) Scottish Swimming National Technical Duet Championship
- cc) Open Mixed Technical Duet Championship
- dd) Scottish Swimming National Mixed Technical Duet Championship
- ee) Scottish Swimming Combined Solo – **Helen Murray Trophy**
- ff) Scottish Swimming Top Club Award - **Glasgow Sports Council**
- gg) Scottish Combination Team Championship - **Avril Dempster Memorial Trophy**
- hh) Open Free Combination Team Championship
- ii) **The Podium Award** – Awarded to Scottish Club with most medals.

SS6.0 Scottish Artistic Swimming National Age Group Figure competition:

SS6.1 General

- SS6.1.1 This competition is open to all affiliated clubs in Scotland and shall be held on a date to be decided by the SSSC.
- SS6.1.2 There is no Free routine section in this competition.
- SS6.1.3 Competitors must enter their Age group.
- SS6.1.4 Age as at midnight on the 31 December in the year of competition.
- SS6.1.5 All details of Figures and Times will be published in the Meet Information Pack.

SS6.2 Awards

- SS6.2.1 Gold, Silver and Bronze medals shall be awarded in each event.
- SS6.2.2 If an event has only 3 swimmers then only Gold shall be awarded.

SS7.0 Licensing

SS7.1 General

- SS7.1.1 Licensing is to provide the Company with a means of control over events and to ensure the maintenance of minimum standards during the operation of these events in Scotland.
- SS7.1.2 Clubs/Organisations running events must be aware of the Health and Safety Regulations and implications in respect of insurance cover
- SS7.1.3 A licence is required for any competitive event that involves two or more participating Clubs.
- SS7.1.3 All swimmers must be members of Scottish Swimming or be registered members of another FINA affiliated country, prior to competing in any licensed meet

SS7.2 License Categories

- SS7.2.1 Event licences will be categorised as follows
 - a) Level 1 - International Meets between two or more Nations and National Meets
 - b) Level 2 - District organised events.
 - c) Level 3 - Other Meets e.g. Regional events, Inter Club Meets, Club events.

SS7.3 Jurisdiction

- SS7.3.1 The SSSC is responsible for the issue of licences for Level 1 and 2 events.
- SS7.3.2 The appropriate District Committee is responsible for the issue of licences for Level 3 events.

SS7.4 Applying for a Licence

- SS7.4.1 Application must be made on the appropriate form available from the Company, which will require the following details.
 - a) Name of organising body
 - b) Contact details, (name, address, day / evening tel / fax numbers, e-mail address)
 - c) Name / Title of Meet
 - d) Date of Meet
 - e) Venue
 - f) Details of Meet – Open or Age groups (specified), list of events.
 - g) Details of pool – Length and maximum and minimum depths.
 - h) Starting and estimated finishing time of sessions.
 - i) Licence type.

- SS7.4.2 Application for level 1 and 2 meets must be made to the SSSC 12 weeks prior to the meet.
- SS7.4.3 Application for a Level 3 meet must be made to the appropriate District committee no later than 8 weeks prior to the meet. A programme of events must accompany the application

SS7.5 Notification

- SS7.5.1 Confirmation that a licence has been granted will be sent to the applicant within 30 days of receipt of the application.
- SS7.5.2 Where a licence application is refused, the applicant will be advised within 30 days of receipt of the application and the reason for refusal stated

SS7.6 Reports

- SS7.5.1 A completed meet report form must be returned by the Referee within 7 days of the finish of the event to the SSSC.

SS7.7 Fees

- SS7.6.1 The fee for each licence category will be set annually in accordance with Company Rule R3.4.1.
